Resolution #6-01-2022
COVID-19 Emergency Resolution

WHEREAS, the World Health Organization has declared the current outbreak of COVID-19 a global pandemic; and

WHEREAS, the Pennsylvania Department of Education has determined that the COVID-19 pandemic constitutes an “emergency” within the meaning of Section 520.1 of the Public School Code; and

WHEREAS, the Board of School Directors has determined that the risks COVID-19 presents to our students, faculty, and community requires an extraordinary response;

NOW THEREFORE, the Board finds and declares that the COVID-19 pandemic is an emergency within the meaning of Section 520.1 of the Pennsylvania School Code.

For the duration of said pandemic but in no event for any period exceeding four years, the Superintendent shall have the duty and the authority to develop a Health and Safety plan in a form and manner prescribed by the Pennsylvania Department of Education that ensures a minimum of 180 days of instruction, allowing for a minimum of 900 hours of instruction at the elementary level and 990 hours of instruction at the secondary level, employing any combination of in-person, virtual, and distance learning as the Superintendent seems appropriate to address the health and safety of students, faculty, and community, and the learning needs of students. Such instruction shall comply in full with the requirement of Chapter 4 of the regulations of the State Board of Education and with the curriculum standards published in accordance therewith.

ARP ESSER Health and Safety Plan Guidance & Template

Section 2001(i)(1) of the American Rescue Plan (ARP) Act requires each local education agency (LEA) that receives funding under the ARP Elementary and Secondary School Emergency Relief (ESSER) Fund to develop and make publicly available on the LEA's website a *Safe Return to In-Person Instruction and Continuity of Services Plan*, hereinafter referred to as a *Health and Safety Plan*.

Based on ARP requirements, 90 percent of ARP ESSER funds will be distributed to school districts and charter schools based on their relative share of Title I-A funding in FY 2020-2021. **Given Federally required timelines, LEAs eligible to apply for and receive this portion of the ARP ESSER funding must submit a Health and Safety Plan that meets ARP Act requirements to the Pennsylvania Department of Education (PDE) by Friday, July 30, 2021, regardless of when the LEA submits its ARP ESSER application.**

Each LEA must create a Health and Safety Plan that addresses how it will maintain the health and safety of students, educators, and other staff, and which will serve as local guidelines for all instructional and non-instructional school activities during the period of the LEA's ARP ESSER grant. The Health and Safety Plan should be tailored to the unique needs of each LEA and its schools and must take into account public comment related to the development of, and subsequent revisions to, the Health and Safety Plan.

The ARP Act and U.S. Department of Education rules require Health and Safety plans include the following components:

1. How the LEA will, to the greatest extent practicable, implement prevention and mitigation policies in line with the most up-to-date guidance from the Centers for Disease Control and Prevention (CDC) for the reopening and operation of school facilities in order to continuously and safely open and operate schools for in-person learning;
2. How the LEA will ensure continuity of services, including but not limited to services to address the students' academic needs, and students' and staff members' social, emotional, mental health, and other needs, which may include student health and food services;

3. How the LEA will maintain the health and safety of students, educators, and other staff and the extent to which it has adopted policies, and a description of any such policy on each of the following safety recommendations established by the CDC:
 - a. Universal and correct wearing of [masks](#);
 - b. Modifying facilities to allow for [physical distancing](#) (e.g., use of cohorts/podding);
 - c. [Handwashing and respiratory etiquette](#);
 - d. [Cleaning](#) and maintaining healthy facilities, including improving [ventilation](#);
 - e. [Contact tracing](#) in combination with [isolation](#) and [quarantine](#), in collaboration with State and local health departments;
 - f. [Diagnostic](#) and screening testing;
 - g. Efforts to provide COVID-19 [vaccinations to school communities](#);
 - h. Appropriate accommodations for children with disabilities with respect to health and safety policies; and
 - i. Coordination with state and local health officials.

The LEA's Health and Safety Plan must be approved by its governing body and posted on the LEA's publicly available website by July 30, 2021.* The ARP Act requires LEAs to post their Health and Safety Plans online in a language that parents/caregivers can understand, or, if it is not practicable to provide written translations to an individual with limited English proficiency, be orally translated. The plan also must be provided in an alternative format accessible, upon request, by a parent who is an individual with a disability as defined by the Americans with Disabilities Act.

Each LEA will upload in the eGrants system its updated Health and Safety Plan and webpage URL where the plan is located on the LEA's publicly available website.

The ARP Act requires LEAs to review their Health and Safety Plans at least every six months during the period of the LEA's ARP ESSER grant. LEAs also must review and update their plans whenever there are significant changes to the CDC recommendations for K-12 schools. Like the development of the plan, all revisions must be informed by community input and reviewed and approved by the governing body prior to posting on the LEA's publicly available website.

LEAs may use the template to revise their current Health and Safety Plans to meet ARP requirements and ensure all stakeholders are fully informed of the LEA's plan to safely resume instructional and non-instructional school activities, including in-person learning, for the current

school year. An LEA may use a different plan template or format provided it includes all the elements required by the ARP Act, as listed above.

* The July 30 deadline applies only to school districts and charter schools that received federal Title I-A funds in FY 2020-2021 and intend to apply for and receive ARP ESSER funding.

1. How will the LEA, to the greatest extent practicable, support prevention and mitigation policies in line with the most up-to-date guidance from the CDC for the reopening and operation of school facilities in order to continuously and safely open and operate schools for in-person learning?

The Hanover Area School District will continue to implement the best practice(s) & current mitigation strategies used throughout the pandemic. We will regularly monitor the transmission rates in the county and school community. This data will be utilized to determine the effectiveness of our efforts and determine when our plan needs to be adapted to better-serve our school community. The HASD will implement any mandates and/or guidance that the Pennsylvania Department of Health and the Center for Disease Control, put forth. As prevention and mitigation procedures evolve, they will then will be addressed by the Hanover Area Pandemic Response Team, resulting in recommendations/adaptations brought to our Board of Education for a formal affirmative vote for change.

2. How will the LEA ensure continuity of services, including but not limited to services to address the students' academic needs, and students' and staff members' social, emotional, mental health, and other needs, which may include student health and food services?

During the 2021-22 school year, the HASD issued chromebooks to implement a 1:1 initiative from grades K-12. (Pre-Kindergarten with iPads) The instructional delivery methods utilized this school year will continually evolve and be tailored to the community need, based on positivity rates. In-person instruction will be utilized until positivity rates deem the physical environment as unsafe. If unsafe conditions arise, the district will shift to a virtual education format. Google classroom is readily available for a seamless transition to create safer educational delivery for students and staff. Special education, social work/counseling & therapeutic services will be executed remotely to assure continuity of services.

We have implemented several summer camps throughout the months of July and August in 2021. English Language Arts, Mathematics, STEM and physical activities focused on remediation & enrichment for students in grades kindergarten through fifth grade. In addition, we have offered free summer school credit recovery for students deficient in grades sixth through twelfth.

Beginning the 2021-22 school year, the HASD will have a School Based Behavioral Health team. The new addition will focus on the mental health needs of students. Also, we have a full-time school psychologist & two licensed social workers to address additional mental health needs.

This COVID-19 mitigation strategy allows for parents to make the decision if their child will be masked throughout the school day. Each school is its own entity with COVID-19 positivity rates. As a result, individual building rates will determine the re-establishment of the mask mandate feature in blue below. 3% positivity rate in each building will prompt the district to re-enact a building specific mask mandate. 5% positivity rate will prompt the HASD to shift to a remote status at that particular building for a 5-day recovery-period of time. <p>Masks are mandated throughout the entire school day. In accordance with the Center for Disease Control, masks must be worn at all times, with the exception of while eating. (Lunch period) This is a district mandate that requires students to wear a mask that covers both the nose and mouth throughout the course of the school day. All staff & students need to adhere to this mandate.</p>

Modifying facilities to allow for <u>physical distancing</u> (e.g., use of cohorts/podding);</p>	<p>Environmental Precautions:</p> <ul style="list-style-type: none"> • Desk Shields will be utilized based on parent choice within the classrooms & cafeteria. • Seating charts in district classrooms, buses & cafeterias for accurate contact-tracing. Each student's location is accounted for, daily. This safety measure creates accurate accountability for student safety & their reference-point to the positive COVID-19 case. (Only if mask mandate is in place.) • Touchless water fountains, sinks and hand dryers are being installed during the months of July and August. This updated strategy reduces the risk of transmission through contact.
<p>c. <u>Handwashing and respiratory etiquette</u>;</p>	<ul style="list-style-type: none"> • Hand sanitizer provided throughout the building.
<p>d. <u>Cleaning and maintaining healthy facilities, including improving ventilation</u>;</p>	<ul style="list-style-type: none"> • Sanitization of high-touch points throughout district buildings. All high touch-points cleaning are documented. • In order to prevent transmission, If positivity rates equate or exceed 3% of a schools population we will eliminate touchpads in the cafeteria. • If positivity rates equate or exceed 3% of a schools population, buses will be sanitized between each school's utilization. Custodial department sprays each seat of our mass transportation with an environmentally friendly chemical, responsible for killing viruses, including COVID-19.

<p>e. <u>Contact tracing</u> in combination with <u>isolation</u> and <u>quarantine</u>, in collaboration with the State and local health departments;</p>	<ul style="list-style-type: none"> ● Contact tracing accuracy diminishes as susceptibility increases. The district's ability to pin-point transmission events significantly decreases, however, awareness will be made of cases in classrooms or positive exposures. ● Families with possible exposure will always have the ability to request a rapid-antigen test by our medical staff by simply utilizing the on-line request for testing form on www.hanoverarea.org. ● Each school is its own entity with COVID-19 positivity rates. As a result, individual building rates will determine the re-establishment of the mask mandate feature in blue below. 3% positivity rate in each building will prompt the district to re-enact a building specific mask mandate. 5% positivity rate will prompt the HASD to shift to a remote status at that particular building for a 5-day recovery-period of time. ● Seating charts are updated tirelessly to assure all contact-tracing is accurate & efficient. Seating charts in the classroom, buses & cafeterias are readily available for immediate responses, if a positive case were to arise. ● CDC & DOH guidelines are strictly adhered to for quarantine & isolation timeframes. ● All positive cases, household & close contacts are entered into a database for collaboration with state & local health departments.

<p>f. <u>Diagnostic</u> and screening testing;</p>	<ul style="list-style-type: none"> ● The HASD has all medical staff (School Nurses) trained in rapid antigen testing & routinely provided on-site testing to any & all students with parental permission. ● The HASD has enrolled in the Ginkgo testing program with the Pennsylvania Department of Health/Education. The program provides free rapid tests to the school district for proactive screening. ● <u>If the positivity rates equate or exceed 3% of the high schools population, the HASD will mandate all student-athletes to be tested on a weekly basis, as a proactive and preventive method.</u> ● www.hanoverarea.org – homepage houses several links for submission to the district concerning diagnostics; <ul style="list-style-type: none"> - Positive Case Submission Form - Vaccination Declaration Form <u>(including booster)</u> - COVID-19 Parent Authorization Form

Efforts to provide <u>vaccinations to school communities</u>;</p>	<ul style="list-style-type: none"> ● During the beginning of the 2021-22 school year, the HASD partnered with the Pediatric Associates of Kingston & Walmart Pharmacy to provide on-site vaccination clinics. In addition, the Wilkes Barre Health Department provided off-site appointments for vaccines.

Appropriate accommodations for students with disabilities with respect to health and safety policies; and</p>	<ul style="list-style-type: none"> ● The district will always provide specified needs per student(s). Any necessary accommodations for staff & students with disabilities pertaining to the health & safety of our community will be adhered to, within the capabilities of the HASD.
<p>i. Coordination with state and local health officials.</p>	<ul style="list-style-type: none"> ● HASD has a longstanding relationship with the Luzerne County Department of Health. We are committed to working with PDE & DOH to implement their guidance & mandates in an effort to provide the safest environment for students & staff. ● Current regulations are; (As of 1/11/22) <ul style="list-style-type: none"> - All buildings are their own entity that require an individualized positivity rate. Each building cannot exceed 5% positivity rate of total school population, within a 14-day period. OR 10% of each building within a 30-day period of time. If exceed, individual buildings experiencing these elevated rates will shift to remote educational format.

<p>J.</p>	<ul style="list-style-type: none"> • In response to the rapidly changing COVID-19 virus & the associated variations, the Hanover Area School District has developed a response plan. The focus of the plan is to optimize the health & safety of both the staff & student-body. Meanwhile, preserving the district's ability to conduct in-person instruction through environmental & personal safety precautions. • The District also has developed educational format levels of operation: <ul style="list-style-type: none"> - Green – Full in-person instruction with the use of CDC & DOH recommendations. - Yellow – Hybrid Instruction, where students & families will be accommodated based on comfort requests. Due to the community health, parents can choose this educational format during the yellow phase only. - Red – Completely virtual instructional delivery. Community health rates are not safe enough for students to be within the buildings of the HASD & instruction will be carried out in a remote format.
